Call to Order: Chairperson Stern called the meeting to order at 6:32 p.m. and announced that the meeting was being video recorded by Norton Cable Access for public record and asked if anyone else was recording at this time.

Chairperson Stern opened the meeting by addressing what a wonderful job the Norton Police and Town Hall did holding the election at the Middle School for the first time.

Public Hearing and Vote on School Choice Program for the 2020-2021 School Year — Dr. Baeta:

The School Choice Program requires a public hearing and then a vote by the School Committee on whether or not to participate the following school year. The current climate of school competition, need for revenue, and the opportunity to provide 21^{st} century learning opportunities for all students clearly allows for us to have a School Choice Program for the 2020-2021 school year with a closing date of September 1, 2020. Further, the School Committee will consider class size issues in K-5 as part of this initiative to include the potential to add staff. A vote and a letter to DESE must be completed by June 1st of each year.

Looking at enrollment projections for the 2020-2021 school year it is recommended that applications be accepted as follows: Kindergarten – Grade 5 – (5) seats; and Grades 6 – 10 no cap. Dr. Baeta and Committee discussed the decline from Kindergarten seats from 10 to 5. This is due to not fully knowing the Kindergarten enrollment and the class sizes. A recommendation date of May 1^{st} can be a cut-off date to determine if the seat count can be adjusted before the notice to DESE.

As of February 7, 2020, there are 138 students enrolled in the School Choice program in the following grades: Kindergarten (10); Grade 1 (14); Grade 2 (14); Grade 3 (12); Grade 4 (11);

Grade 5 (13); Grade 6 (16); Grade 7 (15); Grade 8 (9); Grade 9 (8); Grade 10 (4) and Grade 11 (8); and Grade 12 (4). Please see the enclosed newspaper notice of hearing for School Choice and School Budget.

This budget reflects a 7.66% increase for a total recommended budget amount of \$32,252,090.00.

Review and Vote to Approve Updated Vaping Language for NHS Student Handbook – Dr. Baeta:

Principal Dolleman recommends the following addition to the Smoking and Tobacco Use Guidelines on Page 31 of the Norton High School 2019-2020 Student Handbook. This has gone thru legal counsel as well.

"With the aim of protecting the health and safety of the entire school community, Norton High School may utilize vaping detectors in school bathrooms. Vaping detector technology detects vapor from tobacco and marijuana, as well as detecting loud noises typically associated with aggression, disruption or vandalism, with no audio or video recording taking place. Vaping detectors may be used in concert with hallway surveillance cameras and/or staff supervision to assist the District in determining who engaged in inappropriate and/or prohibited activity. The District will handle any suspicion of vaping activity, aggression, disruption or vandalism, detector related or otherwise, in accordance with its student search and student discipline policies and procedures. A student found to have tampered with a vaping detector will be subject to disciplinary action in accordance with student discipline policies and procedures, as well as being responsible for any property damage caused by the Student's tampering."

- the utility and gas expenditures projected on last year expenditures but need a few more invoices to determine the actual usage and determine what impact the window project will have on this expenditure
- substitute teachers preparing a supplemental for Town Meeting
- SPED transportation preparing a supplemental for Town Meeting
- The Cafeteria account seems to be operating evenly but there are funds in appropriation that we would like to move back into the account.

He presented the Revolving and Grant accounts which are moving along as projected. There were questions and answers from the audience.

Discussion and Vote on Athletic Complex Option - Dr. Baeta:

Dr. Baeta presented a slide show with the recommendation from the Field Study Committee for the new Athletic Complex Option G. He discussed the current complex and the necessary improvements needed. He reviewed the new layout with scenarios, costs associated for this project and future revenue to utilize towards maintenance. This project is recommended at \$8,667,499.
