Dr. Baeta presented the Committee with enrollment data from fiscal years 2015 - 2022. He discussed how the current climate of school competition, need for revenue, and the opportunity to provide 21st century learning opportunities for all students clearly allows for us to have a School Choice program for the 2022-2023 school year with a closing date of September 1, 2022. A vote and notification to DESE must be completed by June 1st of each year. He noted that a minimum of \$3.85M of revenue has been generated by School Choice. Looking at enrollment projections for the 2022-2023 school, it is recommended that applications be accepted for Kindergarten – Grade 10, with no cap.

The Committee commented that without these funds we would be in extreme dire straits. The Committee also thanked the entire NPS staff for the district we have created.

Student Representative Updates

LGN

- The LGN celebrated Read Across America the first week of March. Students from NHS volunteered to read to different classrooms. They celebrated Spirit Days such as: Hat Day; Crazy Sock Day; and Wear a Shirt You Can Read Day.
- Kindergarteners are learning to read. They have been learning about measurement in Math with words "height, length and weight." First Graders are reading like Crazy! They are working on nonfiction teaching books. The Second grade is thrilled to announce that the students will be performing outdoors for the Memorial Day Concert this year. The children have finished their nonfiction writing and are now writing poetry. In math, they are regrouping and will begin to learn about time and money. Third grade students are learning about biographies and creating awesome posters about someone they have researched. They are also in the planning stages for the annual Trip Around Town.

JCS

- JCS is beginning "House" meetings in the newly decorated "Under the Sea" cafeteria. In order to promote more connections among students of different grade levels and to form tighter bonds in the school, JCS is broken up into 5 houses with one class each from PK -3 grade. In these groups, students will do various activities to get to know each other better and be able to have a stronger voice in the goings on of the school.
- Students wanted everyone to know that on Read Across America Day, March 2nd, JCS students read 62,041 words as a collective team and they are very proud of their accomplishment.

HAY

- During the past week, more students are coming to school without masks which enables us to see their smiling faces.
- Starting Thursday, March 10th, we released the restriction on students being able to sit outside their homeroom with their friends. Students were so excited.
- Students participated in an online STEM activity on Wednesday, March 9th, with Jay Mankita from Playful Engineers. We would like to thank the Norton Cultural Council and our PTO for funding this activity.

NHS

- Mr. NHS was a great success for the Class of 2022.
- The girls' basketball team lost a heartbreaker in the "Sweet 16" round of the state tournament to Watertown on Tuesday.
- The boys' basketball team will play an "Elite 8" game in the state tournament against Old Rochester at 2PM on Saturday at Wheaton.
- Indoor track had a great season with 4 runners qualifying for nationals.
- Cheerleading won sectionals and will compete at states on Sunday at Worcester State College
- The Wrestling Team was TVL champs and placed 2nd at the division three sectional meet.

Mid-year and final exams at NHS will be discussed at the June meeting based on a full year's information as provided by the NHS administration.

Staff Welcome Back Day will be August 30th and Staff Professional Development will be August 31st. First day of school for Grades 1-12 will be September 6th, Kindergarten will be September 7th and Little Lancers will be September 8th.

A video from READS was provided to the Committee regarding its Capital Plan and Capital Reserve account. Member districts must approve the Capital Reserve account. The Committee needs to approve the READS Capital Reserve Fund Limit of \$4,000,000 for the following reasons:

1) Maintenance and improvement of READS' properties and leased properties; 2) Provide funding for payment of the lease for READS Academy Public Day School location during periods of time when enrollment is below expectations; and 3) Prepare to purchase the location of the Academy Public Day School to eliminate the expense of a lease beyond 10 years.
