Update on Sharon's Water Supply Walker gave an update of what is happening in Sharon; there are 6 wells in Sharon; wells are coming back up (have been all winter) pumping has been down quite a bit; in August of 2016 we stopped outdoor watering; started with odd/even days from 6-8 PM; assuming the way the weather has been, may shut off the ban; hand held was allowed; with a new lawn kept the use of sprinkle heads to two weeks (being done when someone installed a new septic system and the homeowner owner could call for an extension); our department also sells seed. How did you pass this restriction? Masciarelli: the Selectmen, who are the Water Commissioners, voted it. There is an advisory board also. Sozio noted there is a limit of water for Patriot's Place of 54 gallons per person per day; do not think the drought hit us as much as other towns; wells themselves kept water; there is 5% of water usage unaccounted for; have seven employees; population of Sharon is over 18,000.
- **4. Easton Dedication for Former CRAAC Member John Grant April 22, 2017**Upon hearing a short statement of Mr. Grant's contributions to preserving open space, Boette and Sozio moved to prepare a letter for the John Grant dedication. VOTED
