BOARD OF WATER/SEWER COMMISSIONERS MONDAY OCTOBER 25, 2010

6:30pm

Meeting opened. Commissioners Diane McElligott and Steven Wiseman present. Also present Duane Knapp, Rose Melito, Fran Yanuskiewicz and Attorney Joseph Cove.

Minutes: The minutes of the September 29, 2010 and October 12, 2010 Board Meetings were read, approved and signed as submitted.

Red Mill Village: The Board discussed their previous meeting with Lloyd Geisinger and David Eastridge with Attorney Cove regarding the annual assessment for unused sewer allocation. Chairwoman McElligott stated that they had requested a copy of Attorney Cove's letter of opinion citing case law as well as a copy of the Act itself accepted by the Legislature that allows this assessment. Attorney Cove said he would be happy to contact Mr. Eastridge with the Board's permission.

Irene White: of 74-B Elm Street, came before the Board to dispute her bill. She stated that the water department came out and checked her meter and said it was working properly and the reading was correct but found a hose that could be a leak source as well as a possible leak at the washing machine. She stated that she didn't think she had any leaks and thought it was a problem with the meter. She stated it is a very old meter and was concerned it wasn't registering properly. After much discussion the Board explained how a meter wears with age and its effects, they also discussed the cost of meter testing and the responsibility of payment. They suggested that she monitor her water use, keep track of the water meter readings and if appears that the dial is spinning to call us immediately. She thanked the Board for their time.

<u>Sprint/Nextel:</u> With Kopelman & Paige's approval of the contract the Board reviewed and signed the cell tower agreement. (to be forwarded to BOS for signatures).

Wheaton College: Letters of correspondence dated 10/19/10, 5/8/09, and 12/3/08 were discussed. (copies attached). Attorney Cove said he would contact Attorney Manoogian and follow up in writing if necessary. Fran Yanuskiewicz said he would contact Dave Delorenzo of the DEP to inquire about his response to the December 3, 2008 letter.
