Request from Luke Grant into Concrete Cutting Company on Rt. 123. Look into their use and whether they are paying their bill.

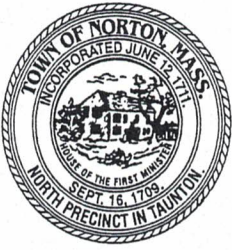
Rules and Regulation session:
