Joseph Baeta: Superintendent Baeta and Wade Lizotte were before the Board to discuss the West Main Street sewer project. Fran Yanuskiewicz gave a brief overview of the project and estimated costs. The schools share will be approximately \$1.234m.

Mr. Baeta stated the school is in support of this project and will have a statement prepared for Town Meeting.

May 15th is the start date for the center tank and both ground storage tanks to be cleaned.

240 South Washington St – water tap complete.

Treatment Plant (signed) contract has been sent to K&P for review and approval as to form.

Weston & Sampson Updates: Sewer – Covered under Joe Baeta.

Water – Reservoir St. bid opening, bids will be reviewed for accuracy. Background and references will be checked. Recommendation to award will follow.

Commissioner Weir motioned to authorize Superintendent Bernie Marshall as an approved signatory on documents for this project. Commissioner Grant seconded the motion. No further discussion. All in favor:
