
BOARD OF WATER/SEWER COMMISSIONERS 166 John Scott Blvd., Norton MA 02766 August 14, 2018



6:30pm. Meeting called to order. Commissioners Luke Grant and Steve Bishop present. Also present Bernie Marshall, Rose Melito, Fran Yanuskiewicz, Barbara Cook and Tara Hourhan.

Action Items: Tabled.

Weston & Sampson Updates: Water- Tara gave an update on the treatment plant construction. The gate valve on Plain Street is scheduled to be cut in on Monday 8/20 and the installation of water main to the site will continue through August. By early September the concrete for the clear well will be poured. Directional drilling will be done mid to end of September.

Barbara discussed the MOA for monitoring costs associated with the treatment facility submitted by the Wampanoag Tribe. Tabled for review and edits. The Board authorized Superintendent Marshall to sign the agreement once finalized.

The electrical easement with National Grid for the treatment facility was reviewed, approved and signed.

Sewer- The MOA with the Norton Housing Authority for the West Main Street Sewer Project is being reviewed and approved by Attorney Cove. (Draft copy submitted to Board). Once approved it will be forwarded to Andrea Downey, Executive Director for NHA and copied to Ben Stone of DHCD.

<u>Superintendent Updates:</u> Reservoir St. Project – Gravity Construction has installed the temporary water main, it has been pressure tested and chlorinated. It will be sampled on Thursday. Also requesting a quote for installing 1100' of 8" D.I. on Holmes Street.

The required Manganese – Public Notification was advertised 8/9/18.

Mr. Marshall informed the Board going forward he would like to schedule Fire Pump and

Hydrant Flow tests at night. The Board approved.

John Harrop has been hired as the new Water Tech – the Selectmen will officially appoint him at their next meeting.

The Board of Selectmen would also like to have a joint meeting regarding water quality. Commissioner Grant stated water and sewer issues can be addressed at either of our next two meetings, 8/28 or 9/11.

Warrant Articles:

Water- Pine Street replace existing cast iron water main with Ductile Iron pipe. Holmes Street replace existing A.C. water main with Ductile Iron pipe.

All appropriately processed bills were signed and correspondence was read.
