Regular meeting called to order: 6:30 pm, at Norton Public Library 68 East Main St, Norton MA

Commissioners: Luke Grant, Steve Bishop and Scott Ollerhead present. Also, present Superintendent Frank Fournier, and Barbara Cook and Tara McManus from Weston & Sampson.

Superintendent Updates: Superintendent Fournier stated the night work had begun on Routes 123 & 140, Sunday August 8, 2019. The first two nights went well with no complaints and then the delays began because of the concert schedule and the Mass DOT limitations. Superintendent Fournier explained work cannot be done any night a concert is scheduled, before, during or after a concert. Also included are no Thursdays before a holiday weekend and the holiday. Superintendent Fournier further explained the delays, work schedules and then distributed the concert schedule for the Boards review.

Superintendent Fournier explained the work and some delays from the Wheaton College project. A concern of storm water runoff was discussed. Conservation Agent Jennifer Carlino is currently assisting to rectify the concerns.

Superintendent Fournier stated Conservation Agent has also allowed the test drilling to begin at wells 5 & 6, this may begin approximately the 2nd week of September.

Superintendent Fournier updated the Board on the new treatment plant. The work is moving along good. Some interior work includes the heaters, electrical and chem feed. Also discussed were the stand pipes supports and concrete pads.

Superintendent Fournier discussed the employee applications. One employee (operator) has been brought back. The employee has 3 years of experience and holds multiple water operator in training licenses. The interview was conducted by the Town Manager and Superintendent Fournier. Further discussion regarding staffing and licensed operators took place.

Superintendent Fournier reviewed with the Board the union updates, creating positions, contract negotiations, and internal movement for open positions.

Prior to completing the regular meeting and starting the scheduled 7 p.m. public hearing, brief discussions to place regarding the DEP inspections, wells, pump to waste and Conservation's involvement.

Meeting adjourned to start the public hearing
