

Call to order

Chairman Corr called the May 2, 2012 Board of Health meeting to order at 6:30 PM.

Newland Farm

Mr. Earl Willcott owner of Newland Farm, Inc., located at 145 Newland Street, Norton explained that he will be applying to MADEP for a determination to allow his compost facility to include dog fish gurry as a component of the material being composted.

Mr. Earl Willcott stated that there should not be any odor from the material when it is delivered because the trucking container is completely enclosed with a hatch door on the top. The material will be delivered between April 15th and September 16th.

Health Agent Dumont stated that the Board of Health's biggest concern is odors from the compost facility; there have been complaints in the past.

Mr. Earl Willcott stated that Eastern Fisheries from New Bedford will be used to transport the fish gurry. He further stated that since the odor problems at the facility last summer he now uses a chemical from Chicago that removes the majority of the odor.

Chairman Corr stated that the Board would like information on other composting operations that are using fish gurry, so that the Board of Health could visit and investigate for itself if there are odor issues.

The Board took no action regarding Newland Farms composting fish gurry at this time, pending more information.

Rules and Regulations

Fee schedule was discussed and compared to Foxborough, Mansfield and Raynham. No action was taken regarding changes to the rules and regulation.

Hooka Bars

Health Agent Dumont stated that the Board of Health was approached regarding allowing a Hooka bar in the town. Upon investigation he had contacted D.J. Wilson, Tobacco Control Director and Mr. Wilson forwarded him draft regulations.

Chairman Corr suggested the secretary look at our Rules and Regulations for smoking and evaluate how these draft regulations could be incorporated into our current and proposed regulations.

Rooming Houses

A brief discussion regarding inspection of rooming houses took place, no action taken.
