#### MINUTES OF NORTON BOARD OF HEALTH MEETING December 10, 2012

The Norton Board of Health held a regular meeting on Monday, December 10, 2012 at 6:30 PM in the 2<sup>nd</sup> Floor Conference Room of Town Hall. The following members were present: Chairman Steven H. Corr, PE, Vice-Chairman Robert B. Medeiros, Clerk Diane Battistello, Health Agent Leon J. Dumont, and Administrative Secretary Cynthia J. Peters.

#### Call to order

Chairman Corr called the December 10, 2012 Board of Health meeting to order at 6:32 PM.

#### **Septic Preservation**

#### Regarding: Dunkin Donuts O & M Sampling

Health Agent Dumont stated he became aware of a septic odor in the area around 416 to 420 Old Colony Road. Upon investigation he realized the odor was coming from Dunkin Donuts located at 420 Old Colony Road.

Health Agent Dumont stated when he visited the property at 420 Old Colony Road, on November 6, 2012, the distribution box cover was floating and the leaching field appeared to be ponding. Agent Dumont contacted Mr. Silvia from Septic Preservation, the company that had installed the White Knight pilot program at 420 Old Colony Road and requested the system be immediately pumped.

Board of Health 12-10-12 Minutes Page **1** of **17**  Health Agent Dumont stated that on November 16, 2012 he again inspected 420 Old Colony Road, the distribution box cover was floating and the field again appeared to be ponding. He contacted Mr. Silvia from Septic Preservation to have the system pumped immediately.

Health Agent Dumont stated on November 21, 2012 he inspected 420 Old Colony Road again and the distribution box was floating and the field was ponding again. He contacted Mr. Silvia from Septic Preservation to have the system pumped immediately.

Health Agent Dumont stated he and Chairman Corr walked the property at 420 Old Colony Road earlier today, December 10, 2012 and the distribution box showed signs that it had previously overflowed.

Chairman Corr stated that the vent at 420 Old Colony Road appeared to be in good condition without any odor. He did indicate that there was a septic odor when standing on the septic tank.

Health Agent Dumont stated that the observation ports on the leaching field had been brought to grade.

Health Agent Dumont asked Mr. Andrea, property owner, about a black plastic  $1\frac{1}{2}$ " diameter pipe on the ground surface near the catch basin. He requested that Mr. Andrea investigate and get back to the Board of Health.

Chairman Corr stated that the White Knight installation at 420 Old Colony Road is a pilot project and required both the Department of Environmental Protection and the Norton Board of Health approvals. As part of this approval the Board required that the inspection ports be monitored monthly for ponding for the first three months and quarterly thereafter for 18 months. Water usages recorded were to be reviewed at each inspection. The White Knight equipment was to be inspected for proper operation during each inspection. This information was to be submitted to the Board of Health within thirty days of the monitoring date accompanied by the inspection form and White Knight technology inspection checklist. The monitoring data was also to be provided to the Department of Environmental Protection. The White Knight and the Certificate of Compliance was signed September 23, 2011. The Norton Board of Health had not received any of documentation as required, nor had the Department of Environmental Protection.

Mr. Silva from Septic Preservation Services, LLC stated he had not realized until recently that the required information had not been sent. Mr. Silva stated that the system had operated with no problems since installation. When he became aware that the White Knight was not functionally properly he had inspected the building and discovered a leaky sink and two toilets that were running continuously.

Chairman Corr stated he would like to know the design flow for the original septic system.

Upon review of the plans and Certificate of Compliance it was determined that the system was designed for 1,200 gallons per day.

Chairman Corr stated he would like to know how many gallons per day Dunkin Donuts is using and how many gallons of water the rest of the building is using.

Health Agent Dumont stated that he would like to know what Septic Preservation's game plan is going to be moving forward.

Mr. Silva from Septic Preservation Services, LLC stated that the system had been completely pumped within the last week and restarted; he would be checking the tanks daily for the next two weeks and check on the total water use for the entire building.

Chairman Corr stated the Board would like to have complete documentation on what has transpired for the next Board of Health meeting, including reports from October 2011 to date. He furthered stated he would like a copy sent to the Department of Environmental Protection.

Board of Health 12-10-12 Minutes Page **2** of **17**  Chairman Corr requested that effluent samples of the BOD and TSS be collected weekly prior to the next meeting. In addition Chairman Corr requested that the system continue to be inspected monthly for the next six months and that Septic preservation submit those reports monthly.

Health Agent Dumont stated that Septic Preservations Services could fax the Board of Health weekly reports.

Chairman Corr stated that the Board could in the future reduce the inspection requirements if the system continued to operate correctly.

#### Todd Drive Extension Condominium O & M Sampling

Health Agent Dumont stated the graphs received for the White Knight system at Todd Drive Extension Condominiums all look exactly the same.

Mr. Silva from Septic Preservation Services stated the reason the graphs all look the same is because the formula was incorrect and provided the Board with a copy of the corrected graphs for review.

Vice-Chairman Medeiros stated the first septic system on Todd Drive Extension on the right hand side failed a Title 5 Inspection recently. Health Agent Dumont stated he would like to see a better explanation on the graphs with modified reports as that is a requirement in the orders of conditions for the White Knight. Test data was to be completed twice a year and the Board of Health has not received any testing data.

Chairman Corr stated he would like to see quarterly reports for the next year showing notes to clarify markings on the graphs. After a brief discussion the following motion was made.

Clerk Battistello made the motion that data be submitted quarterly instead of the requirement of twice a year. Vice-Chairman Medeiros seconded this motion. This motion passed 3-0 M. S. D. V.

#### 246 East Main Street

Chairman Corr stated that no one was present from 246 East Main Street as requested at the November 1, 2012 Board of Health meeting. Chairman Corr stated that he would like to have 246 East Main Street on the January 7, 2013 Board of Health meeting for failing to attend tonight's meeting.

After a brief discussion the following motion was made.

Clerk Battistello made the motion that the Norton Board of Health send 246 East Main Street a letter for failing to appear at tonight's meeting. This letter should inform Mr. Rich III owner of the property that all previous requested data from the November 1, 2012 meeting must be conducted and received in the Board of Health office within seven days from receipt of the letter or he would be fined \$50 per day for each day that the information was not received. They should also be informed that they should appear at the next Board of Health meeting to be held January 7, 2013. Vice-Chairman Medeiros seconded this motion. This motion passed 3-0 M. S. D. V.

#### Dr. Hartman

#### **Regarding Tobacco Purchasing Age**

Dr. Hartman explained that his mission came after earning a Master of Public Health degree. Dr. Hartman stated that he is a local Pediatrician and he believes by increasing the tobacco age requirement to purchase tobacco products from 18 to 21 will reduce the number of children smoking. He further explained though at the age of 18 and individual's brain and body are still developing. Dr. Hartman stated smoking and exposure to second-hand smoke is reduced by changing the age to purchase tobacco products. By delaying access as long as possible you can reduce the potential effect of smoking on the individual. Mr. Hartman indicated that the tobacco industry is targeting the younger population by selling inexpensive cigars manufactured in flavors such as strawberry and bubble gum, and chewing tobacco packaged in tins aimed for attracting young buyers.

Dr. Hartman handed out information packets and requested the Board to review the information. If the Board feels as though they would like more information or would like to change the local regulations please contact either him.

Dr. Hartman thanked the Board for allowing him to speak at tonight's meeting. Dr. Hartman gave the Board members information to review regarding restricting the sale of tobacco products and nicotine delivery produces.

#### **Proposed Rules and Regulations Change**

Ms. Peters explained that she has not had time to work on the Rules and Regulations.
