Call to order: Mr. Medeiros called the meeting to order at 6:00 PM.

New Business:

Norton Country Club, Pumps causing noise issues with neighbors. Norton Country Club representative, Peter Van Heest, spoke of how the noise has been reduced in the past few years and they are still looking to insulate the pumps and shed. DEP has been to golf course and determined that the noise is at a standard level. Norton Country Club is willing to work with the neighborhood to try and alleviate this problem as much as possible.

Discussion on plastic chambers used in septic systems, Chris Zahner, Health Agent, spoke on the issues of chambers and how easy it is to damage them. They are approved by the State but they should be required to use heavy duty ones, so that there is not a chance to be damaged. The Health Agent is going to put a regulation revision in place and bring to next meeting for review.

Diane Battistello made motion to appoint Tobacco Control Agents, Marilyn Edge and Sarah LeRoux thru September, 2018. Mr. Medeiros seconded, approved. Vote 2-0

Jasmine Gardens is requesting a variance to use acidification as a means of preservation of sushi rice. It is approved by State of Massachusetts and the Assistant Health Agent had received and reviewed the HACCP and found everything in order. Ms. Battistello made the motion to approve the use acidification as a means to preserve the sushi rice, Mr. Medeiros seconded.
