Mr. Kimball said copy of bylaws was sent by Police Chief Clark. Mr. Bramwell read aloud letter from Chief Clark. The town of Foxboro is getting involved in this.

Mr. Kimball said it is not approved by Attorney General's office but Norton should "keep an eye on it".

Mr. Kimball said he recommended to see what happens with Foxboro and Norton could possibly adopt bylaw themselves.

Mr. Freeman said he read about this (a civil infraction)/peoples' rights are not protected. It could set a bad precedent and become a money maker. A civil vs. criminal matter.
