- Cpl. Reardon stated the Mansfield Chapter has now been absorbed by the Taunton Chapter as well as Middleboro. Afghanistan/Iraq veterans are returning home with horrendous injuries and need a great deal of care. Disabled American Veterans are always looking for donations. Usually in the Fall they hold this drive. None of this money will be used for administration offices in Boston. Roche Bros. will not give them permission unless Board of Selectmen grants permission to conduct this drive. The Forget-Me-Not drive is local. Administrative fund usually goes toward service for veterans. Donation address is P.O. Box 57, Taunton, MA 02780. For volunteering and info, the public can call 508-823-0409 from usually 9 a.m. to 12 noon. Also volunteers can assist in Forget-Me-Not drive or visit veterans in the hospital. Many veterans are young and some

are in a chronic psych ward with WWII veterans and younger, and are confined there since not able to live on their own. There are many volunteer opportunities such as being a reader, pushing patients in their wheelchairs, etc.

Mr. Kimball stated a lot of veterans are returning from overseas and many are young veterans. Mr. Kimball said he would like to make motion town to include other businesses, not only Roche Bros. (i.e., Dunkin Donuts, etc.). Mr. Kimball said this is a great opportunity for high school seniors/students that need to commit to so many volunteer hours, etc.



Mr. Bramwell said he understood there to be no filing fees.

Mr. Salvo said it is possible he misunderstood.

Mr. Kimball suggested to find out the answer to this.

Mr. Bramwell suggested to send to town counsel for review, etc.
