The Town Manager requested that the Board of Selectmen vote to appoint Christine M. Aveiro as parttime clerk in the Town Accountant's Office. Mr. Yunits indicated that 40 people had applied for the 19 hour/week position and Ms. Aveiro was the best candidate.

The Town Manager reviewed an Agreement he agreed to with Town Accountant , James Puello. The Agreement will be in effect until June 30, 2015. Mr. Yunits said he believed the Agreement was fair in light of other similar positions in neighboring communities. North Attleboro is paying their Town Accountant \$90.000; Easton is at \$96,000; Foxboro has a finance director that is also the Town Accountant at \$112,000.

Mr. Yunits said he met with the Town Accountant and informed him that he could no way meet North Attleboro's offer of \$90,000. The Town Accountant said he was not looking to move, and was sought out by North Attleboro. The Town Accountant felt Norton's offer was fair. The Town Manager said he will put the contract on the next agenda for a vote.
