  - Mr. McPheeney, the Verizon rep, was present and said the request is exactly what petition states; one conduit/concrete encased.

### VI. <u>SELECTMEN'S REPORT AND MAIL</u>

Mr. Kimball said he and Mr. Giblin met with a young man, Anthony Kolodziejczyk, a junior at Norton High School, applying to Military Academy. He needs a nomination by Elizabeth Warren or other state officials as this is an extremely competitive process. This young man is very mature, polite and bright.

Two letters were needed: 1) a letter to support him in applying; and 2) a letter to political figures (and any residents could send letters also). Mr. Kimball said he would work with Michelle Brown, Assistant to Town Manager regarding these letters.

Police Chief Clark sent correspondence, dated May 27, 2015, regarding closure of East Main Street and offered a possible different and more successful way to close roadway.

Mr. Kimball said he also had reservations for shutting down road for two to three weeks.

Mr. Kimball said they can wait until Town Manager returns to discuss this.

Mr. Bramwell said, unfortunately, this road closure will affect businesses also.

Mr. Salvo said the month of July is popular for XFinity Center concerts, whether road construction is ongoing or not.

Mrs. Steele said the developer did come in before the Board. She did not get sense from them that they were going to change anything. She asked to have them in again at next Board of Selectmen meeting along with the Police and Fire Chiefs, with a solution and not a lot of discussion.

Mr. Kimball asked Mr. Bramwell to communicate to Mr. Yunits that the Board of Selectmen is planning to keep one lane open.

Mrs. Steele said as Road Commissioners, she believed the Board of Selectmen is liable if a serious issue occurred, and asked to have Mr. Yunits seek legal guidance on this as well.

Mr. Salvo spoke of the Town's audio/microphone issue and to consider in future anyone in audience wishing to speak needs to stand at podium at microphone for future. He suggested the Town possibly purchase a small PA system for about \$200. It was discussed to possibly have a podium and microphone in rear of room

Access or the School Department.
A certified letter was received from Nutter, McLennen and Fish regarding 0 Leonard Street, Norton. 61A – it is under agricultural tax lien, therefore, gives Town First Option (Right of First Refusal). The Board discussed they were not certain if the Town needed this land and they have 120 days of Rite of First Refusal to make a decision. It was discussed that Town Manager should notify Town departments about this in case it could be utilized.
Mr. Bramwell said the Town can look at this land.
Mr. Kimball said Conservation Department should look at it.
