Victor made a motion to accept Wheaton's feasibility study to go forward with the letter of intent. Board agreed. Victor to write up a letter and the entire Board will sign it.

NHS Press box:

Discussed giving Norton School Dept a donation of \$65,000 to build the press box – it will be an additional \$45,000 to get it ADA accessible.

Victor made a motion and Gretchen seconded to pay \$65,000 towards the purchase and construction and Entire Board voted to agree to this donation. The Board feels this will be a big step towards getting more school and possibility community related activities of things done on the sports fields which the public is interested in seeing.

Jason was asked to publicize this donation.
