• Legislative & Executive Branch

An informal straw poll was taken to get each member's recommendations for the legislative and executive branches. The two members who were absent from the meeting each sent a statement in writing to contribute to the discussion. The following challenges were noted with our current Town Meeting form of government:

- Currently there is a lack of participation at Town Meeting and those who participate are not necessarily representative of the entire town
- Town Meeting is not efficient or effective--by having all the decisions in town being made twice a year, decisions are made too slowly and opportunities are missed
- Lack of accountability
- Nearly impossible for the average citizen to obtain all of the information in order to make a truly educated decision
- Doesn't meet the needs of the town in this day and age
- Modern schedules and responsibilities do not lend themselves to a fully informed Town Meeting member and detract from regular attendance
- Long term Master Plan is impossible to follow given that there are many unknowns with Town Meeting

At the end of the discussion, all seven members in attendance along with the two who sent in statements were in agreement that a Town Council/Town Manager form of government would best address these issues for Norton.
