8:00 pm Continued Public Hearing - O'Loughlin Construction Co.

Representatives from Commonwealth Engineering submitted revised plans concerning the Oak St. water line to the Commission. The plans show erosion controls, drainage channel restoration, etc. Robert Medeiros made a motion, seconded by Earl Willcott to close the Public Hearing. Approved.

8:15 pm Request for Determination - W & G Dev.

Members reviewed a plan for a single family dwelling on lot 13. Earl Willcott made a motion, seconded by John Texeira to issue a Negative Determination contingent upon erosion controls being installed as shown on the approved plans. Approved.

9:00 pm Request for Determination - David Cash Dev. Co.

Lot 4, Beverly Lane-voted to issue a partial Certificate contingent upon a \$1,000 bond being posted by the applicant to cover vegetative stabilization of exposed soils within the 100 ft. Buffer Zone.

Ricaurte, Old Taunton Ave.-Members voted to require a bond to be posted to cover vegetative stabilization of exposed soils before a partial Certificate of Compliance will be issued.
