The members reviewed a request for a Certificate of Compliance filed by Stanson Bldrs., Inc. - bldrs. lot 4, p. 6 (m. 29) Forest Lane (DET. #284). Bob Medeiros made a motion, seconded by Ed Breault, to issue the Certificate of Compliance. Approved.

The members reviewed a request for a partial Certificate of Compliance filed by Kredo Berzins, c/o Paul & Kelly Martin - p. 143, lot 50 (m. 16) Mansfield Avenue (DET. #474). Bob Medeiros made a motion, seconded by Ed Breault, to issue a partial Certificate of Compliance with the condition that the applicant post a \$500 bond with the Norton Town Treasurer to ensure final vegetative stabilization of exposed soil on this lot. Approved.

Mark Bradwin, a Boy Scout, wanting to earn an Eagle Scout Badge, came before the Conservation Commission to see if he could repair the bridge at the North Worcester Conservation area and also make trails there as well. This work will dovetail with the Solmonese School/Mass. Audubon Society Trail and Education project. The Commission's consensus was to approve these activities under the guidance of the Director. Chairman Jeff Houde signed this form.

Bob Medeiros made a motion, seconded by Leonard Silvia, for Ed Breault to look at lot 49, Charlotte Avenue per a letter from the Board of Selectmen dated August 11, 1997. Approved.

Discussion ensued regarding the repairs to the weed harvester. Ed Breault stated that the cost was approximately \$2,200 and it included replacement of steel belts with stainless steel ones.

The Director stated that he would be upgrading a computer donated by the Planning Board for a cost of under \$1,000.00.

The Director stated that he would probably be repairing a vehicle donated by the Building Inspector.

Ed Breault made a motion, seconded by Patrick Corcoran, to adjourn the meeting at 8:15 pm. Approved.
