Jim Burke speaks to the changes that have been made to the plans. At the previous meeting the applicant was asked to add more spot shots to the plans to prove that the area is not ILSF. Jim explains that they found that the area was 4,085 cubic ft of volume. Jurisdictional volume for ILSF is 10,250 cubic ft of volume, which means the area in question is non-jurisdictional. John Thomas mentions that on the plans there is a potential vernal pool. John mentions that if the commission chooses to issue an ORAD that in the Order it be conditioned that the vernal pool is either confirmed with a Notice of intent application or that the applicant concedes that it is
