The Council on Aging meeting was held on March 8, 2012 and called to order at 3:12 PM. P 12:41

Those in attendance were: Tom Bushe, Joan DeCosta, Betty Fogarty, Yolanda Logue, Judy Leroux, Natalie Lima, Tim O'Connell, Ruth Schmieder and Guy Wheeler. Also present was Kay Noel.

The Secretary Report was read, voted to accept and seconded.

Old Business:

It was noted that Tim will not be able to play music at our St. Patrick's Day luncheon. Guy asked if he should bring Irish music and a phonograph and the answer was yes.

Guy will also try to get sheet music of the Irish songs so we could have a sing-a-long.

Also noted we had 32 signed up but would plan for 40. It was decided Italian sub, Tama pie on rolls, beverage and a dessert.

This is being paid for out of our Treasury.

The mill work on the door was \$300 and something so Joan brought over to the Town the bill all filled out and the accountant said this should come out of our budget. Joan said not coming out of the grant. Then told there was a maintenance line item within the Senior Budget. It was noted we were told it would come out of a gift asset. It was mentioned that no one liked the door because it would be too easy for someone to break one of the windows and then get in.

The Treasurer's Report was read noting we paid \$116 for Walmart + BT's which was for valentine luncheon. The balance is \$2061.91. We made

\$145 from yoga in February but this was not applied to March. Motion to accept voted & seconded. It was again discussed that our Treasurer cannot make money but could run the trips. Joan has talked to other CDA as to how they handle money and also to Town Accountants. It has been decided we would purchase another laptop which is needed, keep a few hundred for petty cash and put rest in a donation account with the town so we can use it when needed and get rid of Citizen or Aging accounts. The yoga money received will be put into the donation acct also gumba also. We cannot charge for either activity but suggest a \$2 donation. It was further decided to put yoga and gumba donations with the Friends account.

There was a motion to purchase one more laptop and ²⁵ accessories and to transfer the remaining amount to the Donation Account with the Town.

This was approved.

We will have a petty cash with a maximum of \$200 for immediate supplies.

From now on the Friends will receive and pay for the yoga and gumba and also receive the computer class money.

It was again discussed about the Foxwood gift cards. This trip will be raffled off at the ham & bean supper.

New Business:

It was brought up that the Knights of Columbus want to have a luncheon for Norton Seniors on Saturday, June 2nd at the Parish Center.

Back to Old Business:

The old microwave is still in the closet. It will be brought to by Tom.

Tickets for the ham & bean supper was brought up.

We have them for sale at the Senior Center. My Senior Center Program was again mentioned as a purchase cost of \$3700 plus \$400 for the upgrade and a maintenance fee of \$1200 per year which backs up the system for us. It looks as though we can purchase this with the grant money.
