Transfer request for \$15,000 to account #543-579 D. Charette notes balance in account currently \$15,682. The Town appropriated \$65,000 which was reduced by Executive Secretary from request.

D. Charette notes since July the department has taken on 25 new clients. One client in the hospital without insurance and the Veteran's Agent will need to pay bill at rates set by the Rate Setting Commission usually approx 65%. For clients with insurance the Blue Cross rates increase as of July 1st of \$30 per person.

Currently spending \$6,500 per month of which \$1,000 is medications.

Discussion on referring clients to other agencies.

Review of Finance Committee reserves and pending requests.
B. Nugent suggests transfer of lower figure due to the amount

of requests for funds.
