FINANCE COMMITTEE MEETING MINUTES

September 19, 1990

P. Helmreich notes School Committee and Town Manager to present impact statements regarding cuts.

SCHOOL COMMITTEE

Chairwomen notes request from Finance Committee.

Review reductions made previously.

Chairwomen notes School Dept. was 56.8% of tax rate in F81 and is 46% in F91.

Review of graph provided for average per pupil cost.

Superintendent reviews per pupil cost and notes grants received for the Town for educational grants

for the Town for educational costs.

Superintendent states that Town Meeting voted to keep school budget intact in May and the School Committee feels the Town should use the funds received.

The Superintendent notes Solmonese School repair increased revenues. He reviews test scores provided. He notes project SPOKE for the School Dept and Municipal Center to save funds.

Currently the buses for the schools run 113 runs which is a good value. The buildings are in excellent condition with new roofs.

M. Spillane notes that there is no Business Manager or Assistant Superintendent in the School Department. He also notes that the Finance Committee cannot tell the School Committee were the cuts are to be made because of the school's autonomy with their budget.

M. Spillane notes that if the cuts were to be made, they would have to cut 13 teaching positions. There would be a need for unemployment and medical insurance for 18 months. This would cause an increase class size for elementary students, (Middle School students would not have adolescent education, and would have to drop requirements for High School students.)

M. Spillane reviews costs per pupil, \$3,844/pupil in Norton and \$4,683/pupil State average. He reviews data of Norton students admissions for higher education.

TOWN MANAGER

- S. Lombard notes that reductions will not effect the tax rate or the setting of the tax rate.
- S. Lombard notes the increase in fringe benefits of \$3-4M. He notes that the Town has not had to borrow funds in the past years, therefore, not paying interest charges.
- S. Lombard feels that override if needed would be better than the proposed reductions. He notes a reval override would increase revenues \$316,000.
