

FINANCE COMMITTEE MEETING MINUTES 6/10/92

EMERGENCY MEETING

Chair Hackett called the meeting to order at 6:34 p.m.

- D. Ward made a motion to open Article 8 of the Annual Town Meeting Warrant, seconded by P. Helmreich. In favor: Unanimous. Motion carried.
- P. Helmreich moved that \$13106.76 be transferred to the Accounting Department from the Stabilization Account, seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved that \$1692 be transferred to the Town Clerk Dept., seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved to reaffirm original position on Police #210-510 of \$0.00, seconded by M. Brown. In favor: Unanimous. Motion carried.
- D. Ward moved to open line item 220-510, seconded by P. Helmreich. In favor: Unanimous. Motion carried.
- P. Helmreich moved to reaffirm figure of \$28,825 and not affirm figure of \$54,966, seconded by D. Summerfield, for Fire Department #220-510. In favor: D. Summerfield, P. Zawasky, M. Brown, P. Helmreich. Opposed: D. Ward. Motion carried.
- P. Helmreich moved that Inspection Department #241-510- be \$6883, seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved to reaffirm Tree Warden and Solid Waste, seconded by D. Ward. In favor: Unanimous. Motion carried.
- D. Ward made a motion to add \$10,000 to Cemetery Department, seconded by P. Helmreich. In favor: D. Ward, P. Helmreich, P. Zawasky. Abstain: M. Brown, D. Summerfield.

- P. Helmreich moved that Board of Health be at \$6311.40, seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved that Recreation Department be at \$12590.73, seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved that School Dept. be at \$267,309.39 (#300-571), seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved to reconsider Unemployment Account, seconded by D. Ward. In favor: Unanimous. Motion carried.
- P. Helmreich moved to amend figure for Unemployment to \$0.00 for line #911-570, seconded by D. Ward. In favor: D. Ward, P. Helmreich, P. Zawasky. Opposed D. Summerfield, M. Brown. Motion carried.
- D. Ward moved to adjourn, seconded by M. Brown. In favor: Unanimous. Motion carried.
