Article 6 - Deluca made a motion to transfer \$7,500. Seconded by Thomas. Vote: Unanimous

Article 9 - Deluca made a motion to recommend as amended to allow restriction of hours to be from 9:00am - 4:00pm on Monday through Saturday. Seconded by Thomas. Vote: Unanimous


