Meeting Motions / Actions and Summary of Discussions:

Treasurer's Report: The report for May was reviewed and approved with a motion by Mr. Stefanelli, seconded by Mr. Salvo; all in favor 4-0; The June report was approved with a motion by Mr. Young, seconded by Mr. Stefanelli; all in favor 4-0; 3rd quarter treasurer's reports were reviewed and approved with a motion by Ms. Briggs, seconded by Mr. Stefanelli; all in favor 4-0.

Executive Director's Report:

Timesheets: I worked an average of 32 hours during the month of June.

W/D Account: No deposit was made yet for June; We are looking to purchase 2 new washing machines.

MassNAHRO Offerings were reviewed by the board with no comment.

HILAPP Update: Change Order 2 was reviewed at with the board and approved as presented with a motion by Ms. Briggs, seconded by Mr. Young; all in favor 4-0. Change Order 3 was reviewed at with the board and approved as presented with a motion by Ms. Briggs, seconded by Mr. Stefanelli; all in favor 4-0.

Sewer Project Update: This projects kick-off meeting was July 17th. We're ready to move forward once we have word from Rocchio to tie-in. Unfortunately, ledge is causing an issue and blasting permit approvals are a few weeks out.

JW Roof Project – Change Order 1 for gutters & downspouts throughout the project was reviewed and approved with a motion by Mr. Young, seconded by Ms. Briggs; all in favor 4-0.

WM Light Project Final Completion: The certificate for final completion for the lighting project was reviewed. Comments from one board member included the lights have not been replaced in the stairwells and the lights are too bright, one commenting that the lights look great. Motion to approve the certificate for final completion was made by Ms. Briggs, seconded by Mr. Stefanelli; all in favor 4-0.

WM Garage Roof Change Order & Final Completion: The change order for gable end vents & T111 was approved for Change Order 1 with a motion by Mr. Stefanelli, seconded by Ms. Briggs; all in favor 4-0. Certificate of Final Completion was reviewed and approved by the board with a motion by Mr. Stefanelli, seconded by Ms. Briggs; all in favor 4-0.

JW Bathroom Project: Currently on hold due to Covid-19.

Energy Supplier: Our contract expires 12/21, but prices are lower now than we locked in during 2018. If prices continue to drop, let's call a special meeting to approve the lower amount for 2021.
