Members noted that passive recreation was heavily favored, residents did not appear to know where protected land is located, and there were many comments about zoning. Members agreed to supply other departments (zoning, planning, selectmen etc) with a copy of the results so they can see the comments. Members would like to add a points of interest section to the website with a general town map and points labeled with conservation and recreation properties.
