NORTON PLANNING BOARD MEETING DRAFT MINUTES OF April 2, 2019

The Planning Board Meeting of April 2, 2019 was called to order in the Norton Middle School Auditorium at 7:16 p.m. by Mr. Joseph Fernandes, Chair. Members present were Mr. Timothy Griffin, Mrs. Julie Oakley, Mr. Stephen Jurczyk, Mr. Frank Durant, Mr. Oren Sigal and Mr. Steven Hornsby. Town Counsel, Amy Kwesell was also present.

Continued Public hearing SP. 483: 54 Plain Street Solar Facility- Next Grid Redwood, LLC, Application for Site Plan and Special Permits for a large-scale, ground-mounted solar facility.

SP. 479 Blue Star Business Park (Leonard Street South and Building 7)-Condyne Engineering Group, LLC

Continued Public Hearing for SP-482: Fairland Farm Solar-NextSun Energy, LLC. Application for Site Plan and Special Permits for a large-scale, ground mounted solar facility located on a cranberry bog.

Applicant Adam Schumaker with NextSun Energy present, as well as Stacy Minihane from Beals and Thomas. Landscape Architect, David Lapointe also present to review screening. Board Questions:

- Why did the meeting with the abutters, scheduled for the Sunday before, not occur?
- What is the AC capacity of your project?
- Give a review of the abutters you did speak to and what they liked or dis-liked about the screening
- Were they new abutters or abutters that have already been spoken with?

Attorney Gaines- Represents 20 or so Abutters:

- Submitted letter to the Board this morning
- Gives the abutters take on why the meeting did not occur the Sunday before
- Questions Mr. Fernandes about his proposal about discernable sound to another project and why that was not asked of here?
- Condition with SMART program and ASTGU
- Asks if NextSun is planning to use easement to install and maintain panels
- Does not feel easement should be for such uses other than harvesting the cranberries

Mr. Fernandes addresses Attorney Gaines.

NextSun's attorney also addresses attorney Gaines.

Board questions:

- Member's note that they take information from other projects and consider them in each project, whether the questions are asked or not.
- Would the applicant do a baseline study?
- Are the abutters on Well Water?
- What happens with the status of the Special Permit?

At this time community members had an opportunity to ask the Applicant and Board questions and raise their concerns. The questions and comments focused on health, visual and noise impacts as well as impacts to property values. Mr. Schumaker would like to suggest the board closes the Public Hearing. Board:

- When is your next Conservation Commission meeting?
- Mr. Sigal suggests waiting till after Conservation Commission delivers their decision to decide on this at the site is wetlands.
- Mr. Sigal suggests a peer review be done for the project
- Mr. Sigal suggests moving the meeting till after April 17th.

Motion to continue to next meeting made by Mr. Sigal, Second by Mr. Jurczyk. WITHDRAWN. Motion to get a peer review by a sound engineer, made by Mr. Sigal. Discussion: what does this entail? How long will the review take? Would findings and conditions be done once hearing is closed? Not sure if sound would be applicable for flood plan. WITHDRAWN.

NextSuns Attorney believes Conservation Commission is waiting to hear what Planning Board decides.

Applicant requests the withdrawal of Special Permit without Prejudice for Article XXII.

Motion to withdraw Special Permit for Article XXII without prejudice made by Mr. Griffin, Second by Mr. Jurczyk. All in favor. Motion Passes.

At this time NextSun's Attorney and Town Counsel discuss the legality of how to handle the Site Plan, as the bylaw stands currently.

Motion to close the public hearing for the Special Permit and Site Plan made by Mr. Hornsby and seconded by Mr. Griffin. All in favor. Motion Passes.

Motion to Disapprove the Site Plan as presented made by Mr. Griffin, Second by Mrs. Oakley. (Vote 7-0). Motion Passes.

Motion to Deny Special Permit for Floodplain District made by Mr. Jurczyk, Seconded by Mr. Durant (Vote 4-3)
