## MCAS Presentation

Mrs. O'Neill presented a Power Point overview of 2021 MCAS results. She discussed that being in a hybrid model there still was participation. It was discussed how the only use of the MCAS results are for planning purposes. There is no accountability and some data was not available. She also updated the Committee on new grants, programs and positions.

Mr. Savas clarified that the MCAS results are not an assessment of a teacher's performance. Ms. Shannon Tayler, NTA Representative, also commented it is not a fair assessment.

Mrs. Gallagher asked what the NMS Interventionist duties included. Mrs. O'Neill explained the interventionist provides support to all students regardless if on an IEP or not.

## Review and Vote on NHS Calendar and Mid-Year / Final Exam Schedule

Mr. Ethan Dolleman, Principal, discussed the need to alter the calendar. He reviewed with the Committee the grading percentages for the mid-term and final exams and how it is incorporated into a student's final grade. He also discussed how new assessments his staff has been developing and the benefits to the students and their grades.

Mr. Savas opened the floor to Student Representatives. AnnCatherine Powers read a statement and provided the Committee with a petition and signatures regarding traditional testing and how the students want new assessments for mid-term and final exams. Dr. Baeta advised the statement and the petition would be entered into public record. See attached. Malia Savas also made comments regarding how new assessments for mid-terms and finals would be beneficial for the students.

The Committee heard comments from the audience and discussed how traditional testing may not be a fair assessment for students. A lot of comments and suggestions were brought to the Committee regarding traditional testing for learning versus testing of learning. Dr. Baeta and the Committee agreed that a report after the mid-terms on how each department completed their assessment/testing and the effects would be provided. Mr. Savas thanked everyone for their input and comments.

The half days added to the calendar would be January 26<sup>th</sup>, 27<sup>th</sup>, and 28<sup>th</sup> (already was half day) for mid-terms and the last 3 days of the school year for finals.

## Enrollment Update:

Dr. Baeta presented the Committee with enrollment updates in PK-12, Reads DHH Program, and School Choice. As of November 15<sup>th</sup>, district enrollment was 2,465.

# Athletic Complex 90% Design Update:

Dr. Baeta updated the Committee on the design phase of the project and viewed the 90% design recommendation regarding the project. He expressed his concern about sewer connections and the bidding process in general. Due to inflation, further discussion will need to be about what areas do we start with due to increase in costs.

## Other Business:

• Dr. Baeta thanked the Bristol County Savings Charitable Foundation for their one-time scholarship fund Ronald O'Reilly in the amount of \$2,500.
