Session 1: June 17-20 & 24-27 **Session 3**: July 22-25 & July 29-Aug 1

Swim Level Descriptions:

Adult & Me (ages 2 & 3 with parent) – This is a beginner class and is recommended for children with little or no water experience.

Level 1 – Introduction to water skills and elementary aquatic skills. Students should be comfortable in shallow water.

Level 2 – Fundamental aquatic skills. These students should be able to swim 20 yards without assistance.

Level 3 – Beginning of stroke development. Students should be able to swim 20 yards without assistance.

Level 4 – Stroke improvement and refinement. Students will learn confidence in strokes.

NOTE: Our certified lifeguards lead our swim lessons. If uncertain which level is right for your child, the instructors will evaluate them at a designated time prior to the first session and place them in the appropriate group. Please call 508-285-0228 to arrange for a free evaluation.
