Call to Order: The meeting was called to order at 6:35 p.m.

- 1. Margaret Wood of Pink & Co. (PCI) took the minutes of the meeting.
- Committee members introduced themselves, welcoming Jon Rich to the project.
 Jon thanked the Committee for their selection of WT Rich as Construction
 Manager.
- 3. Margaret noted that the Town had issued a Notice of Intent to WT Rich and that Pinck & Co. was working with the Town's Counsel on finalizing and executing WT Rich's contract, which will be signed by Mike Yunits.
- 4. Jon Rich noted that he met on August 25th with Greg Smolley and Tom O'Neil to discuss phasing. WT Rich incorporated comments made at this meeting into a phasing proposal for discussion at this evening's meeting. Jon presented the proposal (see attached) which includes five phases as follows:
 - Phase I: Construction of new addition (proposed start in March 2012, end December 2012)
 - Phase IA: New mechanical and electrical rooms in existing building (start end of June 2012, end December 2012)
 - Phase IB: Abatement and corridor work (start end of June 2012, end beginning of school year)
 - Phase 2: Renovate existing northeast classrooms on both floors (start January 2012, end March 2013
 - Phase 3: Renovate existing northwest admin space and classrooms (start April 2013, end June 2013)
 - Phase 4: Summer work 2013 (renovate rear of building, both floors)
 - Phase 5: Final building areas (renovate areas adjacent to mechanical and auditorium)
- 5. The upcoming milestones are as follows:
 - September 16th: Design Development estimates due
 - September 23rd: MSBA submittal due

 September 27, 2011: Project update to the Joint Committee (members of the School Committee, Finance Committee, Board of Selectmen and Building Committee)

Friday, October 14th: Homecoming
