

Meeting Motions 201		/ Actions and Summary of Discussions:		

Herb Ellison made motion to approve minutes, Brian Brady seconded the motion

Herb brought up that he did not see any signage for the treatment being done, Carol said she saw the signs but some were removed on the same day. Which happened previously. All four Water Bodies will be treated on August 22, 2017.

Brian said he noticed Winnecunet looked better, Herb said Reservoir looks better and he was out on it, he stopped by Pheeney's Island and picked up some trash.

We are anticipating the By-Law to be passed.

The committee discussed monitoring and signage that needs to be done for future. A question came up, is the treatment worded 'about' 3 years or is it just 3 years. We need to review it. Herb said theoretically the water bodies will not need as much in the following years, but we need to monitor it for the future.

Herb asked about what lies ahead for the Water Bodies Committee.

Brian would like to see a study about the cranberry bogs leaching in and the effects they have.

Herb said that the Mansfield Project will be helpful. Brian said that the EPA helped with Mansfield.

Bogs affect Mulberry. Nitrogen is key ingredient. Acidic, sandy soil, so not retained by bogs and high levels of phosphorous resulting from fertilizers in spring, which is higher when the bogs are flooded. Which allows Nitrogen to be released in the Water Body.

Brian had a copy regarding Fishing Line Recycling, which said how illegal discarding can cause injury and death to many kinds of wild life. "Don't leave Line behind", adopt a recycling bin.
