
## BOARD OF WATER/SEWER COMMISSIONERS 166 John Scott Blvd., Norton, MA 02766 February 3, 2015

The Board agreed. Mr. Geisinger said he would follow up in writing and submit to the Board, with copies to Attorney Peter Freeman and Attorney Ilana Quirk.
